Rule 1

**(V) Student Members**

They shall be persons who have attained the age of 18 years and are enrolled Students in an institution teaching Management subjects or of the AIMA for its Diploma Examination or of Management Association / Institution for its professional examinations shall be eligible for student membership. Application for Student membership shall be sponsored by the Head of the Association / Institution in which the candidate has enrolled himself / herself as a student. No such member shall remain student member after reaching the age of 28 years except those who are pursuing the AIMA Diploma in Management.

They shall, however, have no voting rights and shall not be eligible to be elected to the Managing Committee.
